Subject 1: Review Action Items from the November 2007 Meeting

1) The action assigned to Sherri McMillion to report the status of the meeting regarding using SpecsIntact to produce Design Build Projects was transferred to Carl Kersten. Carl will follow-up with Sherri and report at the next SI-CCCB Meeting.

Subject 2: Maintaining the 01 42 00 Sources for Reference Publications Section

- 1) No impact to the Software as it does not a required the Section
- 2) The options on the Process and Print/Publish will display gray
- 3) Frank Der will request the Legal Department to review to determine if there are legal issues by removing the 01 42 00 Sources for Reference Publications Section.
- 4) Steve Freitas stated the 01 42 00 is a contract requirement.
- 5) SI-CCCB members agreed to have the maintenance of the 01 42 00 Section added to the IHS contract.

Subject 4: Resolution of UFGS Template

- 1) Steve Freitas reviewed the template and made modifications to the template.
- Cheryl Fitz-Simon will incorporate the modifications and distribute for review to SI-CCCB members.

Subject 5: Counting SpecsIntact Users

- 1) Jim Whitehead presented the actual user count, along with some projections.
 - a) After SpecsIntact is permitted to count a user, it will not prompt the user again even if she upgrades to newer SpecsIntact software.
 - b) Users may be prompted to allow SpecsIntact to count them a second time if they acquire a new computer or reinstall Windows..
- 2) In determining how many of the users that we have counted are working on NAVFAC projects, we include:
 - a) users with a navy.mil domain.
 - b) users with the IP address of the Citrix Server
- 3) Discussed whether SpecsIntact should continue to count users. The SI CCCB decided that this feature should remain in the software for now because the user counts provide helpful information. To help distinguish newly counted users from those previously counted, the SpecsIntact developers will add an option to the user counting screen for users to specify whether SpecsIntact has previously counted them.

Subject 6: Status of Table Implementation

- 1) Formatted tables will be available inside SpecsIntact sections.
- 2) The initial release will include the ability to:
 - a) add rows/columns
 - b) merge/unmerge cells

- c) center tables horizontally on a page
- d) use the Editor's Reference Wizard when editing inside a table cell
- e) use tags within table cells (tags are visible only while editing the cell)
- f) undo and redo table insertion (undo and redo will not be available for editing inside table cells)
- g) cut/copy/paste entire tables
- h) create tables that span multiple pages
- 3) Table cells will expand across other cells while being edited, but tables will not automatically expand to ensure that all text is visible.
- 4) Tables can be resized (width and length), but the maximum width is limited to the margins of the page where the table occurs.
- 5) Agencies will have to manually convert the old tables to new tables when Sections are revised.
- 6) Currently 484 UFGS Sections contain the old format tables.
- 7) SpecsIntact will support both the old table format as well as the new improved tables.
- 8) SpecsIntact tables will have to be integrated into our XSL Style Sheet in order for the SI tables to display correctly in a web browser. The SpecsIntact team will update the SI XSL style sheet after the SpecsIntact software is released.
- **9)** A future SpecsIntact release will include the ability to import XML format Excel spreadsheets into SpecsIntact tables using the SpecsIntact Editor.

Subject 7: Review Priority of Work

- SI-CCCB members decided to leave the SpecsIntact development priorities unchanged until the requirements for implementing a file attachment/graphic tag are reviewed at the November SI Meeting.
 - a) Implement Improved Table Handling (Fall 2007)
 - b) Implement a file attachment/graphic tag
 - c) Implement Alternate Paragraph Numbering
